

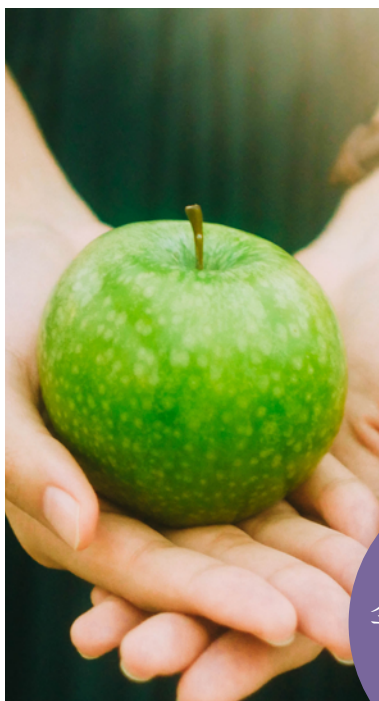

CIOPORA works on continuous improvement and harmonization of systems of Intellectual Property (IP) protection for plants worldwide:

### IP ADVISORY

CIOPORA works on strengthening the systems of IP protection for plants by advising governments on the content of laws and effective enforcement.

### REPRESENTATION

CIOPORA represents plant breeders, promotes and lobbies for their interests before international organizations, governments and industry groups.

### MONITORING

CIOPORA continuously monitors and reports on the global developments in IP for plants as well as the areas of biotechnology and biodiversity.

### EDUCATION ON IP

CIOPORA educates all actors of the horticultural value chain on IP for plants and its economic significance via the CIOPORA Academy program.

### COORDINATION

CIOPORA initiates, runs and coordinates member projects and actions, including enforcement, and facilitates networking and business development.

### COMMUNICATION

CIOPORA compiles, communicates and promotes comprehensive positions on IP and informs its members about important developments in IP worldwide.

## CONTRIBUTION SCHEME

### BREEDER, TITLE-HOLDER & AFFILIATE MEMBERS:

CIOPORA contributions by breeder, title-holder and affiliate members consist of a basic fee and a turnover-related fee. The turnover-related fee\* is calculated on the basis of the company's annual income from breeding and/or royalties as well as from any other activity related to asexually reproduced horticultural varieties.
